### 4. FIRST AID MEASURES

#### First Aid Procedures:

**Inhalation:** Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. WARNING! It may be hazardous to the person providing aid to give mouth-to-mouth resuscitation when the inhaled or ingested material is toxic, infectious, or corrosive. ## 5. FIREFIGHTING MEASURES

<b>Suitable Extinguishing Media:</b>	Water spray, dry powder, alcohol resistant foam, carbon dioxide.
<b>Unsuitable Extinguishing Media:</b>	Do not use a solid (straight) water stream, as it may scatter and spread fire.

## 6. ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions and Protective Equipment:</b>	Ventilate area of leak or spill. Isolate hazard area and keep unnecessary and unprotected personnel away from the area of the leak or spill. Keep upwind. Keep out of low areas. Wear appropriate personal protective equipment (see Section 8). Remove all sources of ignition. Pay attention to flashback. **Methods for Cleanup:**

Absorb spill with an inert material (e.g. vermiculite, dry sand, earth, cloth, or fleece) and place in a non-combustible container for reclamation or disposal. Do not flush to sewer. Clean contaminated surface thoroughly. Never return spills in original containers for reuse. Clean up in accordance with all applicable regulations.

## 7. HANDLING AND STORAGE

**Handling:**

Do not handle, store, or open near an open flame, sources of heat, or sources of ignition. Wear personal protective equipment (see Section 8). Use only in well-ventilated areas. Provide sufficient air exchange and/or exhaust in work areas. Avoid contact with skin, eyes, and clothing. Do not breathe vapors or spray mist. Do not ingest. When using, do not eat, drink, or smoke. Take precautionary measures against static discharge. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from incompatible materials (see Section 10). Handle in accordance with good industrial hygiene and safety practice. Wash thoroughly after handling. Containers of this material may be hazardous when empty, as they retain product residues. Observe all warnings and precautions listed for this product.

**Storage:**

Store in a cool, dry, ventilated area. Store in a segregated and approved area away from incompatible materials (see Section 10). Store in original container. Keep containers tightly closed and upright. Keep away from food, drink, and animal foodstuffs. Keep out of the reach of children. Ground container and transfer equipment. Comply with all national, state, and local codes pertaining to the storage, handling, dispensing, and disposal of this product.
