4. FIRST AID MEASURES

Inhalation: Move to freshair. If breathing is difficult, give oxygen. If not breathing, give

artificial respiration. If symptoms develop and persist, get medical attention.

Skin contact: Do not pull bonded skin apart. Soak in warmsoapy water. Gently peel apart

using a blunt instrument. If skin is burned due to the rapid generation of heat by a large drop, seek medical attention. If lips are bonded, apply warmwater to the lips and encourage wetting and pressure from saliva in mouth. Peel or

roll lips apart. Do not pull lips apart with direct opposing force.

Eye contact: Immediately flush with plenty of waterfor at least 15 minutes. Get medical

attention. If eyelids are bonded closed, release eyelashes with warmwater by covering with a wet pad. Do not force eye open. Cyanoacrylate will bond to eye protein and will cause a lachrymatory effect which will help to debond the adhesive. Keep eye covered until debonding is complete, usually within 1-3 days. Medical attention should be sought in case solid particles of polymerized cyanoacrylate trapped behind the eyelid caused abrasive

damage.

Ingestion: Ensure breathing passages are not obstructed. The product will polymerize

rapidly and bond to the mouth making it almost impossible to sw allow. Saliva will separate any solidified product in several hours. Prevent the patient from

sw allowing any separated mass.

Symptoms: See Section 11.

Notes to physician: Surgery is not necessary to separate accidentally bonded tissues. Experience

has shown that bonded tissues are best treated by passive, non-surgical first

aid. If rapid curing has caused thermal burns they should be treated

symptomatically after adhesive is removed.

5. FIRE FIGHTING MEASURES

Extinguishing media: Water spray (fog), foam, dry chemical or carbon dioxide.

Special fire fighting procedures: Wear a self-contained breathing apparatus with a full face piece operated in

pressure-demand or other positive pressure mode.

6. ACCIDENTAL RELEASE MEASURES

Storage: Keep in a cool, well ventilated area away fromheat, sparks and open flame.

Keep container tightly closed until ready for use.

allergic reaction but due to rapid polymerization at the skin surface, an allergic response is rare. Cyanoacrylates generate heat on solidification. In rare circumstances a large drop will burn the

skin. Cured adhesive does not present a health hazard even if bonded to the skin.

Eye contact: Irritating to eyes. Causes excessive tearing. Eyelids may bond.

Ingestion: Not expected to be harmful by ingestion. Rapidly polymerizes (solidifies) and bonds in mouth. It

is almost impossible to sw allow.
